### 1) Minutes of previous meeting

### 2) <u>Secretary's Report</u>

## 3) <u>Treasurers Report</u>

- 2022 Accounts show:
  - £13,500 light fee income
  - £8100 membership fee income
  - £5400 Final year profit
- This year to date (4 months into membership year):
  - £7400 light fee income
  - £8700 membership fee income
  - £18,450 in bank account
  - £20,000 reserve

# 8) AGM discussion

- Fees
  - Lights fees to increase to £3.50 peak & £2.75 each with an option to increase to £4.00 & £3.00 each if required (due to rapid increase in energy costs)
  - Membership fees:
    - $\circ$  Adult £100
    - $\circ$  Seniors £85
    - $\circ$  Off-Peak £85
    - Student £40
    - Juniors remain £20 & £5
  - Proposal that new members have some funds loaded onto their lights
  - Committee members (Richard Brown and Bob Carroll to step down) all other members happy to stay on in current rolls with the exception of Steve Birss who is stepping down as Chair but is happy to stay on committee.
  - Martin Shaw is proposed as Chairman elect
- 9) <u>Any other business</u>
  - The issue was raised about (lone?) adults changing in front of juniors or when at the club
  - Suggested that to encourage new members by word of mouth a "referral" scheme could be introduced where the member receives some money onto their light account
  - Suggested that Swanland Tennis club be approached about a reciprocal membership arrangement
